#### **NOTICE INVITING TENDER**

#### (Technical Bid)

#### 1) SCOPE OF WORK

Sealed tenders are invited from bonafide, resourceful and competent contractors for execution of works as mentioned below. The bidders shall have to fulfill the criteria of satisfactory execution of works as given below:

- A) Contractor should have experience of at least three similar nature of works.(i.e. maintenance)
- B) Relevant documents consisting of general tender documents and scope of work can also be downloaded from our website (www.hindivishwa.org). The parties who will participate in the tender, are required to deposit the cost of the tender documents Rs 1000/- in the form of a separate demand draft along with necessary documents.
- C) Contractors empanelled with the CPWD/MSEDCL & executing such type of maintenance works with them will be given preference for similar nature of works.
- **D)** Works means the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional.
- E) Site means the land/or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract within the premises of the University.
- **F)** The Contractor means the individual, firm or company, whether incorporated or not, undertaking the works and includes the legal representative of such individual, or the successors of the such firm or company and the permitted assignees of such individual, firm, or company.
- **G)** The Employer means the Officer who is authorized and signs the contract on behalf of the Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya Wardha, and shall be in- charge of the work.
- **H)** The Engineer means the officer who shall supervise the work on behalf of the Employer.
- 1) Accepted Risks are risks due to riots (other than those on account of contractors employees), war (whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, any acts of Government damage from aircraft, acts of God such as earthquake, lightning and unprecedented floods and other causes over which the contractor has no control and accepted as such by the Accepting Authority or cause solely due to use or occupation by

- Government of the part of the works in respect of which a certificate of completion has been issued or a cause solely due to Employer's faulty design of works.
- J) Schedule(s) referred to in these conditions shall mean the relevant schedule(s) of CPWD/MSEDCL with the amendments.
- **K)** Bid Amount means the value of the entire work as stipulated in the letter of award.
- L) The Contract means and includes the documents forming the bids and acceptance thereof and the formal agreement executed between the competent authority on behalf of the MGAHV Wardha, and the bidders, together with the documents referred to therein including these conditions, the specification, designs, drawings and instructions issued from time to time by the Employer and all these documents takes together, shall be deemed to form one contract and shall be complementary to one another.
- **M)** Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
- **N)** The original Contract shall remain with the Employer. The contractor may be furnished, one duplicate copy of the contract documents together with all drawings, if any, as may be forming part of bidding document except standard specification, Schedule of Rates and similar other printed and published documents. None of these documents shall be used for any purpose other than that of this contract.

Offers duly filled in should be submitted along with Earnest Money as stipulated in the notice inviting tender. Earnest Money shall be accepted only in the form given in clause 2. Offers without Earnest Money Deposit will be rejected.

#### • ENVELOPE 2-PRICE BID:

This part shall contain only the professional fees quoted in words and figure. The taxes applicable from time to time payable shall be paid if required and hence did not mention the tax liability in the price bid.

#### 11) Execution of Work

**Works To Be Executed In Accordance With Specifications, Drawings, Orders Etc.:** 

The Contractor shall execute the whole and every part of the work in the most substantial and

workmanlike manner both as regards materials and otherwise in every respect in strict accordance with the specifications. The Contractor shall also conform exactly, fully and faithfully to the design, drawings and instructions in writing in respect of the work signed by the Employer and the Contractor shall be furnished free of charge one copy of the contract documents together with Specifications, designs, drawings and instructions as are not included in the standard specifications specified in Bidding Data or in any Bureau of Indian Standard or any other, published standard or code or, Schedule of Rates or any other printed publication referred to elsewhere in the contract.

The contractor shall comply with the provisions of the contract and with due care and diligence execute and maintain the works and provide all labour and materials, tools and plants including for measurements and supervision of all works, structural plans and other things of temporary or permanent nature required for such execution and maintenance in so far as the necessity for providing these, is specified or is reasonably inferred from the contract. The Contractor shall take full responsibility for adequacy, suitability and safety of all the works and methods of maintenance.

#### **12) IMPORTANT NOTES:**

- i) Offer not containing above information strictly in the required manner shall be liable for rejection.
- ii) Only amount of professional fees shall be read out during the offer opening and no other conditions including Technical details whatsoever.
- iii) University will provide a room space for labour related with 33 K.V. maintenance.
- iv) EPF or Employees Compensation Insurance and ESIC Registration is mandatory for contractor.
- v) Engaged wireman should have legal electrical license.
- vi) Wireman should have minimum 3 year of experience of maintenance related with 11K.V. or 33 K.V.
- vii) Contractor should have proper registration with labour office.
- viii)All the equipment related with maintenance as T&P items(i.e. Megger 5000,Discharge rod, Spanner set, 33KV Hand gloves ,Helmet, Screwdriver, Cutting pier, Safety belt, Ladder, Kamla Clamp, Rope, Hooks, Gum boots, Rubber mat etc.) will be made available by the contractor only.
- ix) Misbehaviour at site will not be acceptable.
- x) Any damage to the labour during the maintenance work will be responsibility of contractor.
- xi) Contractor will produce a self signed certificate that his firm is not black listed in any govt. organization.
- xii) Conditional bid will not be acceptable.

#### 13) RATES TO BE IN FIGURES AND WORDS:

The offerer should quote in English both in figures as well as in words. Discrepancy, if any found between the rates in figures and words of the percentage shown in the offer document the following procedure shall be followed:

When there is a difference between the percentage in figure and words, the percentage in words shall be taken as correct.

#### 14) VALIDITY OF OFFER:

The offer shall remain valid for acceptance for a minimum period of 3 months (three months)

#### 15) CONTRACT AGREEMENT:

Contract document for agreement shall be prepared after award of works to the successful bidder by detailed letter of Intent. Until the final contract documents are prepared and executed this tender document together with the annexed documents, modifications, deletions agreed upon by the Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya, Wardha (Maharashtra) and Bidders acceptance thereof shall constitute a binding contract between the successful Bidder and the University based on terms contained in the aforesaid document and the finally submitted and accepted the percentage professional fees.
