Subject: Admission of KV TC Cases for class II to VIII and Fresh Admissions in KVs -reg.

Madam/Sir,

In continuation to this office letter even number dated 31.07.2024, the following directions are to be given to the Principals of KVs under the Region:

- 1. Seats reserved for RTE and mandated reservation are to be followed, as mentioned in KVS Admission Guidelines 2024-25 for admission of another 8 seats per section in Class 1 in KVs as per priority categories given in Admission Guidelines 2024-25. RTE and reservation are to be calculated for sanctioned strength of Class 40 as a whole.
- 2. While granting admission in Class I, if registered and shortlisted candidates of priority category I and II are not available, admission be granted from priority categories III, IV, V & VI from OLA portal only.
- 3. For other classes, reservation is to be followed in all fresh admissions, in case the average class strength is less than 40. In addition, for admissions up to 45 as instructed in point no. 4 of the said letter for category 1 and 2 in case of Civil/Defence KV and Category 2 and 3 in case of Project/IHL KV of newly joined/mid-term transfer cases of current and previous academic year, if reported, reservation norms will not be applicable as these admissions are beyond the sanctioned class strength.
- 4. KV to KV TC admission cases for Class I will be done similar to other classes.
- 5. The last date for fresh admission in Class I and other Classes is 31.08.2024 for the Academic Session 2024-25.

It is requested to monitor and extend support to Principals of the KVs under the Region for timely completion of the admission process latest by 31.08.2024.
