## CIRCULAR

It has come to the notice of the Competent Authority that some of the employees are indulging in unconstructive, unnecessary and unwarranted criticisms of various policies /administrative decisions etc. of the University and are tarnishing the image of the University by using Social Media Platforms like Twitter, Facebook, Social Networking Groups like WhatsApp, etc. and YouTube Channels. This has been viewed very seriously by the University.

It is hereby informed to all the faculty members, non-teaching staff, staff engaged through Outsourcing Agencies and other persons associated directly or indirectly with the University that, in case, they have acted against the interest of the University and are trying to spoil diminish/damage the image of the University in any manner on Twitter, Facebook, Social Networking Groups WhatsApp and YouTube Channels etc., in such circumstances the University would take strict action against such person(s) and this would also attract disciplinary action against him/her. This amounts to gross misconduct and shall lead to serious disciplinary action against the person(s) doing so, as per the provisions and guidelines of the University Act, Statutes and Ordinances, UGC Regulations, CCS (Conduct) Rules, 1964 and other guidelines of the Government of India.

Therefore, it is emphasized and strongly advised that the faculty members, non-teaching staff and others engaged through Outsourcing Agencies as well as other persons associated directly or indirectly with the University should refrain from giving any opinion in public in freewheeling public debate or posts on social media etc. and YouTube Channels that may tarnish the image of the University.

This is issued with the approval of the Competent Authority and comes in force with immediate effect for strict compliance.
